

**\$90K “VIP Access to Atlanta” Points Race
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away five (5) trips to the 2019 Super Bowl on February 3, 2019 in Atlanta, Georgia, and up to \$7,000 in cash and Bonus Play for a combined value of up to \$90,000 in the “VIP Access to Atlanta” promotion on January 13, 2019.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All Riverwind Wild Card members are eligible to participate in the promotion. All eligible members will be able to earn points on any electronic gaming machines manufactured/distributed by Gaming Capitol Group from 8:00 a.m. on Tuesday, January 1, 2019 through 5:59 p.m. on Sunday, January 13, 2019.
4. The top five (5) patrons who earn the highest number of points on the specified electronic gaming machines during this time period will each be awarded the prize of a trip to the 2019 Super Bowl Game in Atlanta, Georgia (valued up to \$17,000) and \$1,000 in cash. Each trip includes airfare, hotel stay, ground transportation, a Kickoff reception, memorabilia merchandise, two (2) tickets to the game, and spending money. Trips valid for February 2, 2019 through February 4, 2019.
 - a.) Winners will be announced on Sunday, January 13, 2019 at 6:30 p.m. Patrons do not have to be present to win. Winning patrons will be contacted via phone.
 - b.) Winner must accept prize. If not accepting of prize, the prize will be awarded to the next highest point earner.
 - c.) No cash option will be offered in lieu of the prize. Prizes are non-transferable.
 - d.) Limit of one (1) 2019 Super Bowl Game package per patron.
 - e.) Riverwind Casino’s casino management system will be the sole determinant of each winner.
5. On January 13, 2019 all Riverwind Wild Card members will be able to earn entries from 8:00 a.m. to 5:59 p.m. in the following ways:
 - a.) Patrons will earn one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
 - b.) New Members will receive one (1) entry into the drawing by signing up for a Riverwind Wild Card.
6. Drawings will be held every thirty (30) minutes from 2:00 p.m. through 6:00 p.m. where two (2) winners will each receive \$100 in Bonus Play.
 - a.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to respond to North Promotions Booth. However, if the

announced winner does not respond within the allotted time a new winner will be drawn.

- b.) Limit of one (1) win per patron for the above drawings.
 - c.) Bonus Play will be valid from 2:00 p.m. till 11:59 p.m.
 - d.) Riverwind Casino's casino management system will be the sole determinant of each winner.
7. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
 8. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
 9. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
 10. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
 11. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
