- 1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian Tribe. Riverwind Casino is giving away up to \$16,000 in chips during the "Blackjack Green Cash" promotion in March of 2019.
- 2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation's policies; regulations or laws; anyone who has been barred from any of the Nation's gaming facilities; or any promotional sponsors

Upon any dispute resulting from game play, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
