\$14K "March into Money" Promotion Riverwind Casino

Official Rules

- 1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. Riverwind Casino is giving away over \$14,000 in Free Play, and prizes during the "March into Money" GCG promotion.
- 2. Patrons must be 18 years of age or older with a valid photo ID and must be a Riverwind Casino Wild Card member, with complete and accurate information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation's policies, regulations or laws; anyone who has been barred from any of the Nation's gaming facilities; or any promotional sponsors.
- 3. Patrons who are Wild Card members will qualify to spin a wheel once a day on the following dates to either win a swag item (provided by the vendor GCG) valued up to \$5 or \$60 in Free Play. Patrons who win the Free Play will also receive a ticket voucher for a chance to win one (1) of five (5) prizes on the final promotional date at 6:00pm.
 - a.) Monday, March 18, 2019: 3:00 p.m. to 6:00 p.m.
 - b.) Tuesday, March 19, 2019: 3:00 p.m. to 6:00 p.m.
 - c.) Wednesday, March 20, 2019 3:00 p.m. to 6:00 p.m.
 - d.) Thursday, March 21, 2019: 3:00 p.m. to 6:00 p.m.
 - e.) Friday, March 22, 2019: 3:00 p.m. to 6:00 p.m.
- 4. A total of up to \$2,500 in Free Play will be given away on each of the aforementioned dates. Participating patrons will spin a promotional wheel one time to determine their prize varying from gifts valued up to \$5.00 to \$60 Free Play to be played at the selected GCG machines. Limit of forty-one (41) patrons may receive the \$60 Free Play prize each day of the promotion.
 - a.) The awarded \$60 Free Play must be played at specified selected machines at \$5 a spin. Max of twelve spins per patron.
 - b.) Patrons who receive the \$60 Free Play will also receive one (1) raffle ticket to place in a hopper to win a prize.
 - c.) At approximately 6:00pm on Friday, March 22, 2019 five (5) raffle tickets will be drawn and Patrons will receive one (1) of the five (5) following gifts:

- 6. Patrons will have four (4) minutes to respond to the GCG promotional area to claim their prize. In the event of a "No Show" another ticket will be drawn until all five prizes have been claimed.

- 7. No cash option will be offered for any prizes. If for any reason, a patron does not accept a prize, a new winner will be drawn.
- 8. Riverwind Casino's manual drawing system will be the sole determinate of each winner.

- 11. Any situation or dispute not covered by these Official Rules will be resolved by the Chickasaw Nation in a manner deemed by the Chickasaw Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 12. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
- 13. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Chickasaw Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
