

\$15K “Chip into Cinco De Mayo” Promotion

OFFICIAL RULES

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian Tribe. Riverwind Casino is giving away a total of \$15,000 in chips during the **“Chip into Cinco De Mayo”** promotion in the months of April through May, 2019.
2. Patrons participating in the promotion must be 18 years of age or older with a valid photo ID and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred or banned from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning April 1st, 2019 at 8am, and ending at 11:59pm on April 30th, 2019, Patrons that are actively being rated at a Riverwind Casino Table Game with their Wild Card will be eligible to participate in the **“Chip into Cinco De Mayo”** promotion. EZ Baccarat will be the only game not included in this promotion.
 - a) Winners will be determined by the total amount of rated play at Riverwind Casino’s table games in the Blackjack pit.
 - b) Players are responsible to ensure they are being rated at the Tables by checking with staff members if needed.
4. The top 25 Patrons with the most amount of time played will be able to collect an envelope with a prize inside beginning at 8:00 a.m. through 9:00 p.m. on May 5th, 2019. Envelopes will be available for pickup at the Blackjack pits. A Winners list will be posted at the pits for all players to see weekly at 4:00 p.m. on Mondays April 8th, 15, 22, and 29. A final list of winners will be available in the pits at 4:00 p.m. on Wednesday May 1st, 2019. First place through ninth place will receive the following prizes:

 - b) 10th place through 25th place will each receive \$500 in chips.
 - c) Each winning patron must provide a valid photo ID and their Riverwind Wild Card to claim their prize.
 - d) The Top 25 winning patrons must claim their prize by 9:00 p.m. or unclaimed prize funds will be added to random hot seat drawings.
 - e) Riverwind Casino’s casino management system will be the sole determinant of the top 25 rated patrons.
5. Beginning at 9:30 p.m. on May 5, 2019, a random hot seat drawing will take place every fifteen (15) minutes where two (2) winners will each be able to select one (1) envelope from the remaining unclaimed prizes.
 - a) Winners will have two (2) minutes to claim their prize.
 - b) Patrons may win multiple hot seat drawings.
 - c) Drawings will continue until all unclaimed prizes are redeemed.
 - d) In the event that there is no unclaimed prizes from the Top 25 Patrons, no random hot seat drawings will be held.

- e) Riverwind Casino’s manual drawing system will be the sole determinate of each hot seat winner.
- 6. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
- 7. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
- 8. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
- 10. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
