

## **\$30K “Spring Fling” Giveaway**

### **Riverwind Casino**

#### **Official Rules**

1. Riverwind Casino, a governmental enterprise of The Chickasaw Nation (“Nation”), is a federally recognized sovereign Indian tribe. Riverwind Casino is giving away over \$30,000 in Bonus Play and prizes in the month of April on Sundays, April 7, 14, and 28, 2019 for our \$30K “Spring Fling” giveaway.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind WildCard member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning at 8:00 a.m. on Sunday, March 31, 2019 through 7:00 p.m. Sunday, April 28, 2019 Patrons who have a Riverwind WildCard are eligible to earn entries in the following ways:
  - a.) Patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
  - b.) Patrons can earn entries at 5X times the rate on Sundays, March 31, 2019, and April 7, 14, 21, and 28, 2019, and Thursdays, April 4, 11, 18, and 25, 2019.
  - c.) New Member sign-ups will receive one (1) free entry into the promotion.
  - d.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
  - e.) Patrons are responsible for activating their entries by properly inserting their Riverwind Wild card into any electronic gaming device and removing their Riverwind Wild card within thirty (30) minutes of each drawing time each Sunday. Patrons must activate their entries prior to being eligible to win.
4. A total of \$5,000 in Bonus Play will be given away on each of the aforementioned dates. Preliminary drawings will be held every 30 minutes from 2:00 p.m. to 6:30 p.m. were two (2) winners will be drawn to participate in a promotional game to each receive one (1) of the following Bonus Play amounts:
  - a.) Bonus Play will be given away as follows: ten (10) \$200, and ten (10) \$300.
  - b.) Bonus Play will be valid from time won till 11:59 p.m.
  - c.) Patrons may only win one (1) preliminary drawing per promotional date.
  - d.) In the event of a “No Show” another winner will be drawn.
5. At 7:00 p.m. on each of the aforementioned promotional dates a Grand Prize drawing will take place were one (1) winner will win a 2019 Hustler Raptor SD 54” Zero Turn (valued up \$4,099), and a towing trailer (valued up to \$1,300).
  - a.) No cash option will be available in lieu of prize.
  - b.) In the event of a “No Show” another winner will be drawn.
  - c.) All patrons will be eligible for the Grand Prize drawing. Limit of one (1) Grand Prize per patron per promotion.

6. Patrons must be present to win. Winner(s) are given four (4) minutes to respond to the North promotions booth.
7. Riverwind Casino's casino management system will be the sole determinate of each winner.
  - a.) Winner must provide a valid ID and their WildCard to be deemed an official winner of any promotional drawings.
  - b.) Winner must accept prize. If winner does not accept prize, a new winner will be drawn.
8. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
9. Acceptance of prize constitutes winner's permission for the Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
10. Any situation or dispute not covered by these Official Rules will be resolved by the Nation in a manner deemed to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, the Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
11. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
12. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
