Official Rules

- 2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Casino Wild Card member, with complete and accurate account information to participate. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
