Official Rules

- 1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. - 2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Casino Wild Card member, with complete and accurate account information to participate.
