\$225,000 RiverWIN WINniversary (Ford F-150 Raptor) Riverwind Casino

Official Rules

- 1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. Riverwind Casino is giving away up to \$225,000 in cash, Bonus Play, and prizes in the month of August, 2019 with the \$225,000 RiverWIN WINniversary Ford F-150 Raptor and BMW promotions.
- 2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation's policies; regulations or laws; anyone who has been barred from any of the Nation's gaming facilities; or any promotional sponsors.
- 3. Beginning Sunday, July 28, 2019 at 8:00 a.m. through 11:59 p.m. on Friday, August 30, 2019 all Patrons who have a Riverwind Wild Card will be eligible to earn entries for drawings in the following ways:
 - a.) Patrons will earn one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.

 - a.) Finalist spots are not transferable to other patrons.
- 6. On Friday, August 30, 2019 drawings will be held from 7:00 p.m. to 11:30 p.m. and a total of \$10,000 in Bonus Play will be given away as twenty (20) \$500 winners. At 11:59 p.m. the five (5) remaining finalist positions will be filled. Once filled, all thirteen (13) Patrons will participate in a game where each winner will select an item from a Prize Board and will receive the corresponding prize listed on the item. Six (6) Patrons will receive \$1,000 in Bonus Play, six (6) patrons will receive \$1,000 in cash, and one (1) Patron will receive a 2019 Ford F-150 Raptor (Valued at \$65,299).
 - a.) Patrons must be present to win. Winners will be announced and given four (4) minutes to respond. In the event a winner does not respond within the allotted time, a new winner will be drawn.
 - b.) Limit of one (1) preliminary Bonus Play prize per Patron during this promotion date.
 - c.) All Patrons will be eligible for the Grand Prize finalist drawing at 11:59p.m. on August 30, 2019.
 - d.) No Cash Option will be available for the Grand Prize on August 30, 2019.
- 7. Riverwind Casino's casino management system will be the sole determinate of each winner.
- 8. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
- 9. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
- 10. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 11. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
- 12. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
