- 2. Patrons must be 18 years or older with a valid photo ID and must be a Riverwind Wild Card holder, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation's policies, regulations or laws; anyone who has been barred from any of the Nation's gaming facilities; or any promotional sponsors.

  - d) The overall top twenty-five (25) Patrons with the highest scores from Round Two (2) will advance to Round Three (3).
- 7. "Everi-One is a Winner Tournament" Round Three (3) will consist and play as follows:
  - a) Round Three (3) will begin at approximately 4:15 p.m.in the Showplace Theatre.
  - b) Eligible Patrons can only play in one (1) session in Round Three (3).

- 9. Riverwind Casino's casino TournEvent system will be the sole determinant of each winner.
- 10. If for any reason, a game malfunctions during Round One (1) or Round Two (2), that participant or participants will replay their round in a future session with an open seat.
- 11. If for any reason a game should malfunction during Round Three (3), the finals round will be replayed in its entirety. This will ensure everyone has a fair chance to win the tournament.
- 12. If for any reason there is a tie at the conclusion of Round Three (3), the Patrons who tied will play in a one (1) minute "tie breaker" session to determine the tournament winner.

- 15. Any situation or dispute not covered by these Official Rules will be resolved by Chickasaw Nation in a manner deemed by Chickasaw Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 16. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the TournEvent and a forfeiture of any prizes.
