

**“Mega Frenzy Bingo \$5 for \$5 Bonus Play Giveaway”
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away \$5 to Wild Card members that make a \$5 minimum purchase of Mega Frenzy Bingo tickets during our “Mega Frenzy Bingo \$5 for \$5 Bonus Play Giveaway” promotion starting October 2019, and running through December 2019.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Wild Card member, with complete and accurate information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. During the months of October 2019 through December 2019, existing Wild Card members who make a \$5 minimum purchase of Mega Frenzy Bingo Tickets may receive \$5 in Bonus Play
 - a.) Bonus Play offer must be redeemed on the date of Mega Frenzy Bingo ticket purchase.
 - b.) Bonus Play valid until 7:59 a.m. the following day.
 - c.) Limit of one (1) Bonus Play offer per patron per day during this promotion.
 - d.) Winner must provide valid ID and Riverwind Wild Card to be deemed official recipient of any promotional offer.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
