

**“\$80,000 Roarin’ into Riverwind”
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away a total of over \$80,000 in cash and Bonus Play on Tuesday, December 31, 2019.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All patrons who have a Riverwind Wild Card will be eligible to earn entries for drawings Tuesday, December 31, 2019 in the following ways:
 - a.) Beginning on Sunday, December 1, 2019 at 8:00am through 11:59pm Tuesday, December 31, 2019 patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
 - b.) Patrons will receive 5X entries on Mondays, December 2, 9, 16, 23, and 30, 2019, and Tuesdays December 3, 10, 17, 24, and 31, 2019.
 - c.) New Members will receive one (1) entry into the drawing by signing up for a Riverwind Wild Card.
 - d.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
 - e.) Patrons are responsible for activating their entries by properly inserting their Riverwind Wild Card into any electronic gaming device and removing their Riverwind Wild Card within thirty (30) minutes of each drawing time each Friday. Patrons must activate their entries prior to being eligible to win.
4. A total of up to \$80,000 in cash and Bonus Play will be given away on the aforementioned promotional date. Drawings will be held every 30 minutes between 6:00pm and 11:30pm where three (3) winners will be chosen to each receive a prize. All winners will participate in a promotional game where they will pick an object to determine the amount of cash to be won and a separate object to determine the Bonus Play to be won.
 - a.) Prize amounts for cash are as follows: thirty four (34) \$500, and two (2) \$2,020.
 - b.) Prize amounts for Bonus Play are as follows: twenty five (25) \$500, six (6) \$1,020, and five (5) \$2,020.
 - c.) Bonus Play is valid from the time won until 2:00 a.m.
 - d.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to respond to the designated promotional area. However, if the

announced winner does not respond within the allotted time all unclaimed cash prizes will be added to the progressive Grand Prizes at 11:59 p.m.

e.) All unclaimed Bonus Play prizes will be forfeited.

5. At 11:59 p.m. five (5) winners will be selected to each receive a Grand Prize. Each patron will select an item to determine the Grand Prize to be won. Four (4) patrons will each win \$2,020 in cash and \$500 in Bonus Play. One (1) patron will win a progressive Grand Prize of \$20,200 in cash plus any unclaimed cash funds from preliminary drawings.
6. Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the designated promotional area. If the winner does not respond within the allotted time, a new winner will be drawn.
 - a.) Riverwind Casino's casino management system will be the sole determinant of each winner.
7. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
8. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
9. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
10. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
11. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
