Official Rules

- 1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. Riverwind Casino is giving away a total of \$1,500 in Bonus Play for the "Disguises and Prizes" promotion on Saturday, October 31, 2020.
- 2. Patrons must be and 18 years of age or older with a valid photo I.D. and must be a Riverwind Casino Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino: employees of the Nation prohibited from participating as set forth by any of the Nation's policies, regulations or laws; anyone who has been barred from any of the Nation's gaming facilities; or any promotional sponsors.
- 3. Beginning at 4:00 p.m. through 8:59 p.m. on Saturday, October 31, 2020, Patrons that are currently wearing a costume can register to receive a ticket at the North Promotions booth. All tickets will be placed into a hopper to be eligible for a chance to win one (1) of three (3) Bonus Play prizes of \$500 each.
 - a.) Patrons must legibly place their name and account number on the entry ticket to be eligible to win.
 - b.) NO WEAPONS allowed real or replica or any device that could be used as a weapon.

- final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
