

**\$40,000 “Holidays on Us” Giveaway**  
**Riverwind Casino**

**Official Rules**

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away over \$40,000 Bonus Play and prizes in the \$40,000 “Holidays on Us” Giveaway” promotion on Saturday’s in December 2020 excluding December 26th.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All patrons who have a Riverwind Wild Card will be eligible to earn entries for drawings each Saturday, December 5, 12, and 19, 2020 in the following ways:
  - a.) Beginning on Sunday, November 29, 2020 at 8:00am through 11:00pm Saturday, December 19, 2020 patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
  - b.) Patrons will receive 5X entries on Thursdays, December 3, 10, and 17, 2020.
  - c.) New Members will receive free one (1) entry into the drawings by signing up for a Riverwind Wild Card.
  - d.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
  - e.) Patrons are responsible for activating their entries by properly inserting their Riverwind Wild Card into any electronic gaming device and removing their Riverwind Wild Card within thirty (30) minutes of each drawing time each Saturday. Patrons must activate their entries prior to being eligible to win.
4. Drawings will be held on each of the aforementioned promotional dates where every 30 minutes between 7:00pm and 10:30pm three (3) winners will be chosen to each receive \$400 in Bonus Play.
5. At 11:00pm, two (2) Grand Prize winners will be drawn and each will receive a \$2,000 Gift Card Bundle. The Gift Card Bundle includes one (1) of each of the following: one (1) \$400 gift card to Target, one (1) \$400 gift card to Walmart, one (1) \$400 gift card to Best Buy, one (1) \$400 gift card to Amazon, and one (1) \$400 Visa gift card.
  - a.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the promotional booth. However, if the announced does not respond within the allotted time, a new winner will be announced.
  - b.) Bonus Play will be valid from the time won until 2:00am.
  - c.) Limit of one (1) preliminary prize per patron, per night during this promotion.
  - d.) All patrons are eligible for Grand Prize drawing.
  - e.) Riverwind Casino’s casino management system will be the sole determinant of each winner.

- f.) Winner must provide valid ID and Riverwind Wild Card to be deemed official winner of any promotional drawings.
  - g.) Winner must accept prize. If not accepting of prize a new winner will be drawn.
6. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
  7. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
  8. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
  9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
  10. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
