

**“A Night Out Payout”  
Riverwind Casino**

**Official Rules**

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away a total of \$66,000 in cash and Bonus Play throughout the months of January, February, and March; for our “A Night Out Payout” promotion beginning Thursday, January 7, 2021 through Thursday, March 25, 2021, with the exclusion of Thursday, January 21, 2021.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning at 8:00am each Thursday throughout the months of January, February, and March, 2021 patrons can qualify for drawings in the following ways:
  - a.) Patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawing begin.
  - b.) Patrons who are new card sign ups during the promotional period will receive one (1) entry upon initial enrollment.
  - c.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
  - d.) Patron(s) are responsible for activating their entries by properly inserting their Riverwind Wild Card into any electronic gaming machine and removing their Riverwind Wild Card from the machine within thirty (30) minutes of each drawing time, to be eligible to win.
4. Every Thursday preliminary drawings will be held from 5:00pm to 8:30pm and a total of \$4,000 in cash and Bonus Play will be awarded. At the top of each hour, two (2) male Patrons will be drawn and at every half hour, two female Patrons will be drawn. All winners will be able to participate in a promotional game to claim a prize. Preliminary cash prizes to be won are: two (2) \$100, two (2) \$200, two (2) \$300, and two (2) \$400. Preliminary Bonus Play prizes to be won are: two (2) \$100, two (2) \$200, two (2) \$300, and two (2) \$400. At 9:00pm, one (1) male Patron will be drawn and at 9:30pm one (1) female Patron will be drawn to each receive a Grand Prize of \$1,000 in Bonus Play plus any unclaimed preliminary prizes.
  - a.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to respond to the promotions booth. If the announced winner for a preliminary drawing does not respond within the allotted time, those prizes will be added to the respective Grand Prize totals. If the announced winner for a Grand Prize does not respond within the allotted time, a new winner will be drawn.
  - b.) Patrons must provide a valid ID and Riverwind Wild Card to be deemed an official winner of any promotional drawings.
  - c.) Bonus Play will be valid from time of download till 2:00 a.m each Thursday.
  - d.) Riverwind Casino’s casino management system will be the sole

- a.) Riverwind Casino's casino management system will be the sole determinant of each winner.
  - e.) Limit of one (1) preliminary drawing prize per Patron, per promotional date. All Patrons will be eligible for the respective Grand Prizes. Limit of one (1) Grand Prize per Patron per promotional night.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
  6. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
  7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
  8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
  9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
