Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away a featured gift item each week to qualifying Patrons during the “Points and Prizes” weekly gift giveaway.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Casino Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning Sunday, January 3, 2021 at 8:00 a.m. through 7:59 a.m. on Sunday, March 28, 2021, Patrons will be able to earn the featured gifts during qualifying time periods, while supplies last.
 - a.) Patrons who earn 500 points on their Riverwind Wild Card while playing on the specified electronic games during the qualifying time periods listed below must check in at the Players Services desk to receive the featured gift of the month. Points earned will carry over from week to week within the same months qualifying time frame until an accumulated 500 points is achieved and redeemed towards that month’s gift. Points will reset for each new qualifying gift time frame.

 - Gifts may be redeemed each week from 8:00 a.m. Fridays through 7:59 a.m. Sundays.
4. Riverwind Casino’s casino management system will be the sole determinant of each winner.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before prize will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
