Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away \$6,000 in prizes during the “Kitchen Cash In” Points Race.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Casino Player’s Club Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All Riverwind Casino Wild Card members who redeemed at least two monthly gifts from our Kitchen Cash In gift giveaway are eligible to earn points on any electronic gaming machines manufactured/distributed by American Gaming Systems (AGS), Gaming Capital Group (GCG), or Everi during the qualifying period. The qualifying period is as follows:
 - a.) Qualifying Period: 8:00 a.m. April 1, through 12:00 p.m. April 30, 2021.
4. The top patron who earn the highest number of points on the specified electronic gaming machines during the qualifying period will win one (1) \$6,000 appliance voucher on 5:00 p.m. April 30th.
 - a. Winner will be announced on Friday, April 30th, 2021 at 5:00 p.m. Patrons do not have to be present to win.
 - b. Winner(s) will be contacted via phone.
 - c. No cash option will be offered in lieu of the prize. Prizes are non-transferable.
 - d. Riverwind Casino’s casino management system will be the sole determinant of each winner.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before prize will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
