\$15K "Top O' the Winnings" Riverwind Casino

Official Rules

- 1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. Riverwind Casino is giving away up to \$15,000 in cash and Bonus Play on Saturday, March 13, 2021.
- 2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation's policies, regulations or laws; anyone who has been barred from any of the Nation's gaming facilities; or any promotional sponsors.
- 3. Beginning at 8:00a.m. on Monday, March 1, 2021 through 10:00 p.m. on Saturday, March 13, 2021, Patrons who use their Riverwind Wild Cards can qualify for entries into drawings in the following ways:
 - a.) Patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
 - b.) Patrons will earn entries at 5X the rate on Sunday, March 7, 2021.
 - c.) Patrons who are new card sign ups during the promotional period will receive one (1) free entry into the promotion.
 - d.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
 - e.) Patron(s) are responsible for activating their entries by inserting their Riverwind Wild Card into an electronic gaming device and removing their Riverwind Wild Card within thirty (30) minutes of each drawing time. Patrons must activate their entries to be eligible to win.
- 4. A total up to \$15,000 in cash and Bonus Play will be given away on Saturday, March 13, 2020. Preliminary drawings will be held every thirty (30) minutes between 5:00p.m. and 9:30p.m. where two (2) winners will be chosen to each receive a prize. All winners will participate in a promotional game where they will pick an object to determine the amount of cash or Bonus Play won.
 - a.) Prize amounts for cash are as follows: six (6) \$300 and three (3) \$400. Prize amounts for Bonus Play are as follows: six (6) \$500, four (4) \$1,000, and one (1) \$2,000.
 - b.) Bonus Play is valid from the time won until 2:00 a.m.
 - c.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to respond to the promotional booth. However, if the announced winner does not respond within the allotted time, the prize will be unclaimed. All unclaimed cash from preliminary drawings will be added to the progressive Grand Prizes at 10:00 p.m. and split evenly between the two winners.
 - d.) All unclaimed Bonus Play will be forfeited.

- e.) Limit of one (1) preliminary prize per Patron during this promotion.
- f.) All Patrons are eligible for the Grand Prize.
- 5. At 10:00 p.m. two (2) Grand Prize winners will be selected to each win \$1,000 in cash and \$500 in Bonus Play plus any unclaimed cash from the preliminary drawings.
 - a.) Limit of one (1) Grand Prize per Patron during this promotion.
 - b.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to respond to the promotional booth. However, if the announced winner does not respond within the allotted time, a new winner will be drawn.
 - c.) Bonus Play is valid from the time won until 2:00 a.m.
- 6. Riverwind Casino's casino management system will be the sole determinant of each winner.
- 7. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
- 8. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
- 9. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 10. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
- 11. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
