

**\$20,000 Hometown Hot Seats  
Riverwind Casino Table Games**

**OFFICIAL RULES**

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away a total of \$20,000 in chips during the “\$20,000 Hometown Hot Seats” giveaway.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Every Wednesday and Thursday in September 2021, random hot seat drawings will be held from 7:00pm until 10:00pm and a total of eight (8) winners will be chosen each night. In order to qualify for random selection a Patron must be actively playing a live rated hand at a blackjack table during the time of each drawing.
  - a) A total of eighty (80) winners will be selected during this promotion and the following prize amounts will be awarded in chips: Fifty-two (52) (\$200) prizes, Twenty-two (22) (\$300) prizes, and six (6) (\$500).
  - b) Patrons are responsible to ensure they are being rated at the table by presenting their Riverwind Wild Card to the Table Games staff members.
  - c) If there is not a rated player in the seat chosen, a new table and seat will be drawn.
  - d) Patrons may win multiple hot seat drawings.
  - e) Riverwind Casino’s manual drawing system will be the sole determinant of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
