Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away up to \$15,000 in Bonus Play to Patrons with a valid Military/Veteran ID during the “\$15,000 Veterans & Victories” promotion on Thursday, November 11, 2021.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Casino Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning Thursday, November 11, 2021 the first 200 Patrons that bring in a valid Military/Veteran ID to the North Promotions Booth desk from 12:00 p.m. to 9:00 p.m. will be registered into drawings from 5:00 p.m. to 9:00 p.m. and receive \$25 in Bonus Play.
 - a. Beginning at 8:00 a.m. Thursday, November 11, Patrons will earn one (1) entry every five (5) points earned on their Riverwind Wild Card.
 - b. Patrons who register between 12:00 p.m. and 3:00 p.m. will receive an additional fifty (50) entries into the drawings.
 - c. All Bonus Play is downloadable to any participating electronic gaming machine. Non-participating machines will be denoted with a placard on the machine.
 - d. Bonus Play is non-cashable, non-transferable credits and will be deposited directly into the Patron’s Bonus account.
 - e. Patrons are only eligible to redeem one (1) \$25 Bonus Play offer.
 - f. Patrons are responsible for activating their entries by properly inserting and removing their Riverwind Wild Card into any electronic gaming device within thirty (30) minutes of each drawing time. Patrons must activate their entries prior to being eligible to win.
4. Beginning at 5:00 p.m., we will draw three (3) Patrons every 30 minutes to receive \$250 in Bonus Play. At 9:00 p.m. we will draw two (2) Grand Prize winners to each receive \$2,000 in Bonus Play.
 - a. Patron(s) must be present to win. Winner(s) will be announced and have four (4) minutes to respond to the North Promotions Booth. However, if the announced winner does not respond within the allotted time, a new winner will be drawn.
 - b. Winners must provide a valid ID and Riverwind Wild Card to be deemed the official winner of any promotional drawings.
 - c. Limit of one (1) preliminary prize per Patron.
 - d. All Patrons will be eligible for the Grand Prize. Limit of one (1) Grand Prize per Patron.
 - e. Riverwind Casino’s casino management system will be the sole determinant of each winner.

5. All Bonus Play will be valid from 12:00 p.m. to 2:00 a.m.
6. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
7. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
8. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
10. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
