## "Super Points and Super Plays" Riverwind Casino

## **Official Rules**

- 1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. Riverwind Casino is giving away five (5) trip packages to the 2022 Super Bowl Game in Los Angeles, California in the "Super Points and Super Plays" promotion on January 29, 2022.
- 2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino: employees of the Nation prohibited from participating as set forth by any of the Nation's policies, regulations or laws; anyone who has been barred from any of the Nation's gaming facilities; or any promotional sponsors.
- 3. All Riverwind Wild Card members will be able to earn points on all electronic gaming machines manufactured/distributed by Gaming Capitol Group from 8:00 a.m. on Saturday, January 1, through 3:00 p.m. on Saturday, January 29, 2022.
- 4. The top five (5) patrons who earn the highest number of points on the specified electronic gaming machines during this time period will be awarded the prize of a trip to the Super Bowl Game in Los Angeles, California (valued at \$23,000) and \$1,000 in cash. Each trip includes airfare, hotel stay, ground transportation and two (2) tickets to the game. Trips valid for February 11, 2022 through February 14, 2022.
  - a.) Winners will be announced on Saturday, January 29, 2022 at 5:00 p.m. Patrons do not have to be present to win.
  - b.) Winners will be contacted via phone. Once contacted, patrons will have twenty-four (24) hours to call and claim the prize. If not accepting of prize, or if the patron does not call to claim prize within the allotted time, the prize will be awarded to the next highest point earner.
  - c.) No cash option will be offered in lieu of the prize. Prizes are non-transferable.
  - d.) Limit of one (1) Super Bowl Game package per patron.
  - e.) Riverwind Casino's casino management system will be the sole determinant of each winner.

On Saturdays, January 1, 8, 15, 22, and 29, 2022, beginning at 12:00 p.m. through 4:00 p.m., every thirty (30) minutes two (2) Patrons will be selected in random hot seat drawings for a chance to win \$100 in cash. Patrons must be actively playing on select electronic machines manufactured/distributed by Gaming Capital Group (GCG) to qualify for random selection.
  - a.) In order to qualify as "actively playing", a patron must have their Riverwind Wild Card properly inserted in an electronic gaming machine at the time of each drawing and have placed a wager at the machine within five (5) minutes of the drawing time.
  - b.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the Promotional Booth. However, if the announced

winner does not respond within the allotted time the prize will be unclaimed. All unclaimed cash prizes will be added to the progressive Grand Prize at 4:30 p.m.

  - a.) All patrons are eligible for Grand Prize drawing.

- 9. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
- 10. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 11. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
- 12. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
