

**“16 Wishes to Winnings”
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away Bonus Play and prizes in the month of August, 2022.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Patrons will be able to earn points on any electronic gaming machine during the qualifying times frames to redeem an envelope. Qualifying time frames are as follows:
 - a.) Sunday, July 31, 2022 at 8:00 a.m. through 11:59 p.m. on Thursday, August 4, 2022.
 - b.) Sunday, August 7, 2022 at 8:00 a.m. through 11:59 p.m. on Thursday, August 11, 2022.
 - c.) Sunday, August 14, 2022 at 8:00 a.m. through 11:59 p.m. on Thursday, August 18, 2022.
4. The first 200 Patrons who earn 200 points during each of the qualifying **time** frames will be able to redeem on Saturday’s, August 6, 13, and 20, 2022 from 12:00 p.m. through 6:00 p.m. **Each Patron will receive** an envelope which will contain one (1) of the following prizes, while supplies last:
 - a.) Cash in the denominations of \$250, \$400, and \$500.
 - b.) Bonus Play in the denominations of \$50, \$75, \$100, \$150, and \$250.
 1. All Mystery envelopes must be opened in the presence of a Player Services Representative or Promotions Associate. Any envelope opened without a Player Services Representative or Promotions Associate present and opened prior to the aforementioned times will be void.
 2. All Mystery envelopes are non-transferable and must be redeemed at **the North Promotions desk**. No cash option will be awarded in lieu of prizes won.
 3. All Bonus Play will be valid from time won until 2:00 a.m.
 4. Limit of one (1) prize per Patron for each qualifying time frame.
5. Patrons will be able to earn points on any **participating** electronic gaming machine during the qualifying **time** frames. Qualifying time frames are as follows:
 - a.) Sunday, August 21, 2022 at 8:00 a.m. through 11:59 p.m. on Thursday, August 25, 2022.
6. The first 200 Patrons who earn 200 points during each of the qualifying time frame will be able to redeem on Saturday, August 27, 2022 from 12:00 p.m. through 6:00 p.m. for an envelope which will contain one (1) of the following prizes, while supplies last:

- a.) Cash in the denominations of \$500, \$800, \$1,000, and \$1,600.
- b.) Bonus Play in the denominations of \$100, \$150, \$200, \$300, and \$500.
 - 1. All Mystery envelopes must be opened in the presence of a Player Services Representative or Promotions Associate. Any envelope opened without a Player Services Representative or Promotions Associate present and opened prior to the aforementioned times will be void.
 - 2. All Mystery envelopes are non-transferable and must be redeemed at the North Promotions desk. No cash option will be awarded in lieu of prize won.
 - 3. All Bonus Play will be valid from the time won until 2:00 a.m.
 - 4. Limit of one (1) prize per Patron for each qualifying time frame.
- 7. Riverwind Casino's casino management system will be the sole determinate of each winner.
- 8. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
- 9. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
- 10. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 11. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
- 12. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
