

**“Race to the Red River”
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away three (3) trip packages to the Red River Showdown on August 26, 2022.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All Riverwind Wild Card members will be able to earn points on all electronic gaming machines from 8:00 a.m. on Monday, August 1, through 12:00 p.m. on Friday, August 26, 2022.
4. The top three (3) patrons who earn the highest number of points on electronic gaming machines during this time period will be awarded the prize of a trip to the Red River Showdown (valued at \$2,910). Each trip includes hotel stay, ground transportation, and two (2) game day tickets. Trips valid for October 7, 2022 through October 9, 2022.
 - a.) Winners will be announced on Friday, August 26, 2022 at 5:00 p.m. Patrons do not have to be present to win.
 - b.) Winners will be contacted via phone. Once contacted, patrons will have twenty-four (24) hours to call and claim the prize. If not accepting of prize, or if the patron does not call to claim prize within the allotted time, the prize will be awarded to the next highest point earner.
 - c.) No cash option will be offered in lieu of the prize. Prizes are non-transferable.
 - d.) Limit of one (1) Red River Showdown trip per patron.
 - e.) Riverwind Casino’s casino management system will be the sole determinant of each winner.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
