Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away \$30,000 in cash in the “Awesome Games and Awesome Paydays” promotion in November and December, 2022.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Each Friday, November 25th through December 16th, 2022 beginning at 5:00 p.m. through 10:00 p.m., every thirty (30) minutes three (3) Patrons will be selected in random hot seat drawings for a chance to win a cash prize.
 - a.) Preliminary prize amounts for cash are as follows: thirty (30) \$200.
 - b.) Patrons must be actively playing on specified electronic machines manufactured/distributed by Gaming Capital Group (GCG) to qualify for random selection.
 - c.) In order to qualify as “actively playing”, a patron must have their Riverwind Wild Card properly inserted in an electronic gaming machine at the time of each drawing and have placed a wager at the machine within five (5) minutes of the drawing time.
 - a.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the Promotional Booth. However, if the announced winner does not respond within the allotted time the prize will be unclaimed. All unclaimed cash prizes will be added to the progressive Grand Prize at 10:00 p.m.
 - b.) Limit of one (1) preliminary prize per patron.
4. At 10:00 p.m. one (1) Grand Prize winner will receive \$1,500 in cash plus any unclaimed promotional cash.
 - a.) All patrons are eligible for Grand Prize drawing.
 - b.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the Promotional Booth.
 - c.) If the announced winner does not respond within the allotted time, a new winner will be drawn.
 - d.) Riverwind Casino’s casino management system will be the sole determinant of each winner.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.

6. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
