

**\$80,000 “New Beginnings and Winnings” Giveaway
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away up to \$80,000 in cash and Bonus Play on Saturdays in June, 2023.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All patrons who have a Riverwind Wild Card will be eligible to earn entries for drawings each Saturday, June 3, 10, 17, and 24, 2023 in the following ways:
 - a.) Beginning on Sunday, May 28, 2023 at 8:00 a.m. through 11:59 p.m. Saturday, June 24, 2023 patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
 - b.) Patrons will receive 5X entries on Mondays, May 29, and June 5, 12, and 19, 2023, and Tuesdays, May 30, and June 6, 13, 20, 2023.
 - c.) New Members will receive one (1) free entry into the drawing by signing up for a Riverwind Wild Card.
 - d.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
 - e.) Patrons are responsible for activating their entries by properly inserting their Riverwind Wild Card into any electronic gaming device and removing their Riverwind Wild Card within thirty (30) minutes of each drawing time each Saturday. Patrons must activate their entries prior to being eligible to win.
4. A total up to \$20,000 in cash and Bonus Play will be given away on each of the aforementioned Saturdays. Preliminary Drawings will be held every 30 minutes from 6:00 p.m. to 11:30 p.m. where three (3) winners will be chosen to each win a prize. All winners will participate in a promotional game where they will pick an object to determine the amount of cash or Bonus Play won.
 - a.) Prize amounts for cash are as follows: eight (8) \$300, four (4) \$400, and four (4) \$500.
 - b.) Prize amounts for Bonus Play are as follows: nine (9) \$400, eight (8) \$500, one (1) \$600, one (1) \$800 and one (1) \$1,000.
 - c.) Limit of one (1) preliminary drawing win per patron per promotional date.
 - d.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the promotional booth.
 - e.) In the event of a “No Show” all unclaimed cash from preliminary drawings will be added to the progressive grand prize at 11:59 p.m.

- f.) All unclaimed Bonus Play prizes will be forfeited.
- 5. At 11:59 p.m. two (2) Grand Prize winners will be selected to win \$1,000 in Bonus Play and \$1,000 in cash plus any unclaimed preliminary cash.
 - a.) All patrons are eligible for the Grand Prize drawing.
 - b.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the promotional booth.
 - c.) In the event of a “No Show” a new winner will be drawn until Grand Prize has been claimed.
- 6. All Bonus Play won from Preliminary and Grand Prize drawings is valid from the time won until 2:00 a.m.
- 7. Riverwind Casino’s casino management system will be the sole determinant of each winner.
- 8. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
- 9. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
- 10. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
- 11. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
- 12. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
