

**\$100,000 Electric Winnings Giveaway
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away over \$100,000 in cash, Bonus Play, and prizes in the month of November 2023 with the \$100,000 Electric Winnings Giveaway.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning Sunday, October 29th, 2023 at 8:00 a.m. through 11:59 p.m. on Saturday, November 25, 2023 all Patrons who have a Riverwind Wild Card will be eligible to earn entries for drawings in the following ways:
 - a.) Patrons will earn one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
 - b.) Patrons will earn entries at 10X the rate on Mondays, October 30 and November, 6, 13, 20, and Tuesdays, October 31 and, November 7, 14, 21, 2023.
 - c.) New Riverwind Wild Card members will receive one (1) entry into the drawing upon initial signup.
 - d.) Patrons are responsible for activating their entries by properly inserting and removing their Riverwind Wild Card into any electronic gaming device within thirty (30) minutes of each drawing time. Patrons must activate their entries prior to being eligible to win.
4. Over \$25,000 in cash, Bonus Play, and prizes will be given away on each of the following Saturdays: November 4, 11, 18, and 25, 2023. Preliminary drawings will be held every 30 minutes between 6:00 p.m. and 11:30 p.m. where three (3) winners will be chosen to each receive a prize. All winners will participate in a promotional game where they will pick an object to determine the amount of cash, Bonus Play, or prize won.
 - a.) Preliminary cash prize amounts are as follows: eight (8) \$300, four (4) \$400, and two (2) \$500.
 - b.) Preliminary Bonus Play prize amounts are as follows: nine (9) \$400, eight (8) \$500, one (1) \$600, one (1) \$800, one (1) \$1,000.
 - c.) Preliminary Gift Card amounts are as follows: two (2) \$500 Visa gift cards prizes.
 - d.) Limit of one (1) preliminary prize per patron, per promotional date.
 - e.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the promotional booth. If not present, a new winner will be drawn.
 - f.) Bonus Play is valid from time won till 2:00 a.m.
5. At 11:59 p.m. each promotional date two (2) Grand Prize winners will be selected to participate in a promotional game to receive of the following grand prize packages valued at (\$3,947.77): One (1) 85” S Class 4K UHD HDR LED Smart TV w/ Google TV, One

- a.) In the event a winner for the Grand Prize drawings does not respond within the allotted time, a new winner will be drawn until the Grand Prize has been claimed.
 - b.) No Cash Option will be available for any electronic prizes.
 - c.) All patrons are eligible for the Grand Prize drawing.
 - d.) Riverwind Casino's casino management system will be the sole determinant of each winner.

 7. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
 8. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
 9. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
 10. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
 11. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
