

**“\$30,000 Blooming Bucks and Bonus”
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away over \$30,000 in cash during the “Blooming Bucks and Bonus” promotion on Saturday, April 13th and 27th, 2024.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Casino Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. On Saturdays, April 13th and 27th, 2024 beginning at 6:00 p.m. through 11:30 p.m., every thirty (30) minutes two (2) Patrons will be drawn in random hot seat drawings for a chance to win \$250 in cash and \$250 in Bonus Play. Patrons must be actively playing on any electronic gaming machine to qualify to win a hot seat drawing.
 - a) Patrons must be present to win. Winner(s) will be allowed four (4) minutes to respond to the designated promotional area. However, if the announced winner does not respond within the allotted time, a new winner will not be drawn, and prize amounts will be added to Grand Prize
 - b) Limit of one (1) preliminary prize per Patron.
4. At 11:59 p.m. two (2) Grand Prize winners will be selected, and each will receive \$500 in cash and \$1,000 in Bonus Play plus any unclaimed preliminary cash amounts.
 - a) Patrons must have play on their Wild Card within thirty (30) minutes prior to each drawing time to be deemed active for a chance to win a hot seat drawing.
 - b) Patrons must be present to win. Winner(s) will be allowed four (4) minutes to respond to the designated promotional area. However, if the announced winner does not respond within the allotted time, a new winner will be drawn.
 - c) Limit of one (1) Grand Prize per Patron per drawing date.
5. Riverwind Casino’s casino management system will be the sole determinate of each winner.
6. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/ or a 1099 tax form, when applicable provided by the Chickasaw Nation.
7. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
8. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the

right to void any entry, and/ or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
10. Participation in this promotion and/ or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
