**OFFICIAL RULES**

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away up to \$283,500 in Chips during the month of January 2026 through April 2026 during the “Fastbreak Frenzy” giveaway.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Every Sunday, Monday, and Tuesday starting Sunday, January 4, 2026, through Tuesday, April 12, 2026, Riverwind Table Games will be having Hot Table drawings every hour from 2:00pm – 4:00pm, 4:00pm – 6:00pm, and 2:00am – 4:00am. In order to qualify patrons must be actively playing a live rated hand at any qualifying table game during the time of each drawing.
  - a) Each patron playing a live rated hand at the time of a drawing will be eligible to be awarded a prize amount in Chips.
    - i. Patrons at the winning table who are playing a live rated hand and have their “Thunder Coin” will receive \$100 in Chips.
    - ii. Patrons at the winnings table who are playing a live rated hand and does not have a “Thunder Coin” will receive \$50 in Chips.
  - b) Patrons are responsible to ensure they are being rated at the table by presenting their Riverwind Wild Card to the Table Games staff members.
  - c) Patrons may win more than one (1) Hot Table drawing per day.
4. Prizes are non-transferable.
5. Craps, and Roulette are excluded from this promotion.
6. Riverwind Casino’s casino manual hopper system will be the sole determinant of each winner.
7. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form and/or 1042s tax form, when applicable, provided by the Chickasaw Nation.
8. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before prizes will be released.
9. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

10. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
11. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
