

**“\$30,000 Shamrockin’ & Spins”  
Riverwind Casino**

**Official Rules**

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away over \$30,000 in Cash and Bonus Play during the “\$30,000 Shamrockin’ & Spins” promotion on Saturday, March 21, 2026.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Casino Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All patrons who have a Riverwind Wild Card will be eligible to earn entries for drawings Saturday, March 21, 2026, in the following ways:
  - a) Beginning on Sunday, March 1, 2026, at 8:00am through 11:59pm Saturday, March 21, 2026, patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
  - b) Selected patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
  - c) Patrons are responsible for activating their entries by properly inserting their Riverwind Wild Card into any electronic gaming device and removing their Riverwind Wild Card within thirty (30) minutes of each drawing time. Patrons must activate their entries prior to being eligible to win.
4. Over \$30,000 in Cash and Bonus Play will be given away on March 21, 2026. Preliminary drawings will be held every one (1) hour from 6:00pm to 11:00pm where five (5) winners will be chosen to each receive a prize. All winners will participate in a promotional game to determine the amount they will receive.
  - a) Prize amounts for cash are as follows: six (6) \$450, six (6) \$500 and four (4) \$550.
  - b) Prize amounts for Bonus Play are as follows: four (4) \$750, four (4) \$800, four (4) \$850, and two (2) \$1,500.
  - c) Limit of one (1) preliminary drawing win per patron per promotional date.
  - d) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the promotional booth. However, if the announced winner does not respond within the allotted time or, decline the said prize a new winner will be drawn.
  - e) All bonus play won during the preliminary drawing will be valid until 2:00am.
5. At 11:59pm two (2) Grand Prize winners will be announced to win \$2,500 in Cash and \$2,500 in Bonus Play.

- a) All patrons are eligible for the Grand Prize drawing.
  - b) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the promotional booth.
  - c) In the event of a “No Show”, or a winner decline the said prize a new winner will be drawn until the Grand Prize has been claimed.
  - d) One (1) grand prize drawing win per patron, per promotional date.
  - e) All Bonus Play won from the grand prize drawing will be valid until 7:59am.
6. Riverwind Casino’s casino management system will be the sole determinate of each winner.
  7. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form and/or a 1042s tax form, when applicable, provided by the Chickasaw Nation.
  8. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
  9. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/ or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
  10. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
  11. Participation in this promotion and/ or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
