

**“\$6,000 Triple Double”
Table Games
Riverwind Casino**

OFFICIAL RULES

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away over \$6,000 in Chips and prizes during the month of April 2026 during the “Triple Double” Promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Starting at 8:00am on Friday, February 20, through 7:59am on Sunday, April 12, 2026, Patrons will receive one (1) hour of play for every hour of rated played on a qualifying Riverwind Table Game. To qualify for an entry a Patron must be actively playing at any qualifying table game during the time of the earning period and present their “Thunder Coin” that was issued in the month of December 2025 and January 2026.
 - a) Patrons are responsible for ensuring they are being rated at the table by presenting their Riverwind Wild Card to the Table Games staff members.
4. The top ten (10) Patrons who earn the most hours of rated play during the promotional time periods will be awarded an amount in chips depending on placement and a “Limited City Edition Oklahoma City Thunder Jersey” (valued at \$120). The following chip amounts are as follows:
 - a) First (1st) place will win \$1,000 in chips.
 - b) Second (2nd) through third (3rd) place will win \$700 in chips.
 - c) Fourth (4th) place through sixth (6th) place will win \$500 in chips.
 - d) Seventh (7th) through ninth (9th) place will win \$300 in chips.
 - e) Tenth (10th) place will win \$200 in chips.
 - f) A leader board will be posted with the top fifteen (15) patrons at 10:00am each Tuesday during the promotional period.
5. 10:00am on Tuesday, April 14, 2026, the top ten (10) patrons will be announced and contacted by a member of the Riverwind Casino Table Games Staff.
 - a) The top ten (10) winners will be able to claim their prize from 10:00am Tuesday, April 14, 2026, until 7:59am Saturday, April 18, 2026.
 - b) Winners may only win one (1) Chip Prize and one (1) Jersey per promotion.
 - c) Winners do not have to be present to win and will be contacted via phone.
 - d) Prizes are non-transferable.
6. All rated table games play is eligible for this promotion.
7. Riverwind Casino’s casino management system will be the sole determinant of each winner.
8. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form and/or 1042s tax form, when applicable, provided by the Chickasaw Nation.
9. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes are released.

10. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
11. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
12. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
