

**“\$15,000 Mother’s Day Royale”
Sweepstake Drawings
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away over \$15,000 in Cash and Bonus Play during the “\$15,000 Mother’s Day Royale” promotion on Saturday May 9, 2026.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning on Friday, May 1, 2026, at 8:00am through 11:59pm on Saturday, May 9, 2026, all Patrons who have a Riverwind Wild Card will be eligible to earn entries for drawings in the following ways:
 - a.) Patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
 - b.) Patrons will receive entries at 15X the rate on Sunday May 3, 2026.
 - c.) Patrons who are New Member sign-ups during the promotional period will receive five (5) free entry into the drawings.
 - d.) Patrons are responsible for activating their entries by properly inserting and removing their Riverwind Wild Card into any electronic gaming device within thirty (30) minutes of each drawing time. Patrons must activate their entries prior to being eligible to win.
 - e.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
4. Drawings will be from 6:00pm to 11:30pm every 30 minutes, where two (2) winners will be selected to each win a prize. All winners will participate in a promotional game where they will pick an object to determine the amount of Cash or Bonus Play won.
 - a.) Prize amounts for Cash are as follows: three (3) \$400, three (3) \$450, two (2) \$500, and two (2) \$550.
 - b.) Prize amounts for Bonus Play are as follows: five (5) \$500, four (4) \$550, three (3) \$700, and two (2) \$800.
 - c.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the North Promotion’s Booth.
 - d.) In the event of a “No Show” or the potential winner declines said prize, a new winner will be drawn.
 - e.) Preliminary Bonus Play is valid from the time won until 2:00am.

5. At 11:59pm one (1) Patrons will be selected to receive a Grand Prize of \$1,000 in Cash and \$1,500 in Bonus Play.
 - a.) Patrons must be present to win. Winners will be announced and given four (4) minutes to respond to the North Promotion's Booth. However, if the announced winner does not respond within the allotted time or decline said prize, a new winner will be drawn.
 - b.) All Patrons will be eligible for the Grand Prize drawing at 11:59pm.
 - c.) Grand Prize Bonus Play is valid from the time won until 7:59am.
6. Riverwind Casino's casino management system will be the sole determinant of each winner.
7. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, and/or 1042s tax form, when applicable, provided by the Chickasaw Nation.
8. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
9. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner. 4
10. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
11. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
