

**“\$30,000 Dive In & Win”  
Hot Seat Drawings  
Riverwind Casino**

**Official Rules**

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away a total of \$30,000 in Cash and Bonus Play during the “\$30,000 Dive In & Win” promotion on Saturdays, July 11, and July 25, 2026.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Riverwind Casino Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
- 3) All patrons who have a Riverwind Wild Card will be eligible to participate in our Hot Seat drawings on Saturdays, July 11, and July 25, 2026, through the following ways:
  - a) Patrons must be actively playing on electronic machines with their Riverwind Players Club Card properly inserted at the time of each drawing time to be deemed active for a chance to win a Hot Seat drawing.
- 4) A total of \$15,000 in Cash and Bonus Play will be given away on each Saturday, July 11<sup>th</sup> and 25<sup>th</sup>, 2026. Preliminary drawings will be held every 30 minutes from 7:00pm through 11:30pm, where two (2) winners will be chosen to receive a prize. All winners will participate in a promotional game to determine the amount they have won.
  - a) Prize amounts for Cash are as follows: nine (9) \$500, and one (1) \$1,000.
  - b) Prize amounts for Bonus Play are as follows: nine (9) \$500, and one (1) \$1,000.
  - c) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the North Promotion’s Booth.
  - d) All Bonus Play won from the Preliminary drawings is valid from the time won until 2:00am the following morning.
3. At 11:59pm one (1) Grand Prize winner will be announced to win \$2,000 in Cash and \$2,000 in Bonus Play.
  - a) All patrons are eligible for the Grand Prize drawing.
  - b) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the North Promotional Booth.
  - c) All Bonus Play won from the Grand Prize drawing will be valid until 7:59am the following morning.
4. If the announced winners do not respond in the allotted time or declines the said prize a new winner will be redrawn.
5. Limit of one (1) Preliminary drawing prize and one (1) Grand Prize drawing prize per patron per promotional date.

6. Patrons must provide a valid ID and Riverwind Wild Card to be deemed an official winner of any promotional drawings.
7. Riverwind Casino's casino management system will be the sole determinate of each winner.
8. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form and/or a 1042s tax form, when applicable, provided by the Chickasaw Nation.
9. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
10. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/ or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
11. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
12. Participation in this promotion and/ or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
