

**“\$100,000 Mid-Summer Marvels”
Sweepstake Drawings
Riverwind Casino**

Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away a total of \$100,000 in Cash and Bonus Play during our “\$100,000 Mid-Summer Marvels” promotion in July 2026.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All patrons who have a Riverwind Wild Card will be eligible to earn entries for drawings each Friday, July 3, 10, 17, 24, and 31, 2026 in the following ways:
 - a.) Beginning at 8:00am on Sunday, June 28, 2026, through 11:59pm on Friday, July 31, 2026, patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
 - b.) Patrons will receive 9X entries on Mondays, June 29, 2026, through July 27, 2026, and Tuesdays, June 30 through July 28, 2026.
 - c.) New Members will receive five (5) free entries into the drawing by signing up for a Riverwind Wild Card in July.
 - d.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
 - e.) Patrons are responsible for activating their entries by properly inserting their Riverwind Wild Card into any electronic gaming device and removing their Riverwind Wild Card within thirty (30) minutes of each drawing time. Patrons must activate their entries prior to being eligible to win.
4. Each Friday from 6:00pm to 11:30pm, Cash and Bonus Play will be given away during Preliminary drawings. Every 30 minutes two (2) winners will be selected to win a prize and then participate in a promotional game where they will pick an object to determine the amount of Cash or Bonus Play won.
 - a.) Prize amounts for Cash are as follows: five (5) \$550, three (3) \$650, three (3) \$700, one (1) \$1,200.
 - b.) Prize amounts for Bonus Play are as follows: six (6) \$600, two (2) \$800, two (2) \$900, two (2) \$1,000
 - c.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the North Promotional Booth.
5. At 11:59pm one (1) Grand Prize winner will be selected to win \$2,000 in Cash and \$1,000 in Bonus Play.

- a.) All patrons are eligible for the Grand Prize drawing.
 - b.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to report to the North promotional booth.
6. All Bonus Play won during the Preliminary and Grand Prize drawings will be valid from the time won until 2:00am the following morning.
 7. Limit of one (1) Preliminary drawing prize and one (1) Grand Prize drawing prize per patron, per promotional date.
 8. Patrons must provide a valid ID and Riverwind Wild Card to be deemed an official winner of any promotional drawings.
 9. If the announced winner does not respond in the allotted time or declines the said prize a new winner will be redrawn.
 10. Riverwind Casino's casino management system will be the sole determinant of each winner.
 11. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, and/or 1042s tax form, when applicable, provided by the Chickasaw Nation.
 12. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
 13. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
 14. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
 15. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
