

**“\$29,000 Riverwind Legendary 20”
Table Games / Rated Play
Riverwind Casino**

OFFICIAL RULES

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away over \$29,000 in Chips during the month of July 2026, and August 2026, during the “\$29,000 Riverwind Legendary 20” Promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Starting at 8:00am on Wednesday, July 1, 2026, through 11:59pm on Thursday, July 30, 2026, and starting at 8:00am on Saturday, August 1, 2026, through 11:59pm on Thursday, August 27, 2026, patrons will receive one (1) hour of play for every hour of rated played on a qualifying Riverwind Table Game. To qualify for an entry a Patron must be actively playing at any qualifying table game during the time of the earning period.
 - a) Patrons are responsible for ensuring they are being rated at the table by presenting their Riverwind Wild Card to the Table Games staff members.
 - b) Rated play will not carry over month to month.
4. The top twenty (20) patrons who earn the most hours of rated play during the promotional time periods will be awarded an amount in Chips depending on placement. The following chip amounts are as follows:
 - a) First (1st) place through third (3rd) place will win \$500 in Chips, and an “Key to the Vault” on August 28, 2026.
 - b) Fourth (4th) place through tenth (10th) place will win \$300 in Chips.
 - c) Eleventh (11th) place through twentieth (20) place will win \$100 in Chips.
 - d) A leader board will be posted with the twenty-five (25) patrons at 10:00am each Friday during the promotional period.
 - e) Patrons will not be given a physical key at the time they have won, however each of the top three (3) patrons of each month must return on Friday, August 28, 2026, to play a game for the Grand Prize amount.
5. 10:00am on Friday, July 31, 2026, and Friday, August 28, 2026, the top twenty (20) patrons will be announced and contacted by a member of the Riverwind Casino Table Games Staff.
 - a) The top twenty (20) winners that are announced on July 31, 2026, will be able to claim their prize from 10:00am Friday, July 31, 2026, until 7:59am Wednesday, August 5, 2026.
 - b) The top twenty (20) winners that are announced on August 28, 2026, will be able to claim their prize from 10:00am Friday, August 28, 2026, until 7:59am Wednesday, September 2, 2026.
 - c) Patrons will be eligible to win more than one (1) Chip Prize amount.
 - d) Winners do not have to be present to win and will be contacted via phone.

6. 9:00pm on Friday, August 28, 2026, the top six (6) patrons who were the top three (3) winners on July 31, 2026, and August 28, 2026, will be eligible to qualify in the Grand Prize Drawing.
 - a) Qualifying patrons will play a game where one (1) winner will win \$20,000 in Chips.
 - b) Winners may only win one (1) Chip Prize.
 - c) Winners must be present to win.
7. Prizes are non-transferable.
8. All rated table games play is eligible for this promotion.
9. Riverwind Casino's casino management system will be the sole determinant of each winner.
10. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form and/or 1042s tax form, when applicable, provided by Chickasaw Nation.
11. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes are released.
12. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
13. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
14. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
