

“Employee/Patron Blood Drive”
Riverwind Casino
Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away Bonus Play to Riverwind Casino Employees and Patrons who donate blood on September 9, 2026, between 10:00am – 6:00pm.
2. Eligible Employees and Patrons must be 18 years of age or older with a valid photo I.D. and is a Riverwind Wild Card member with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity: employees of Chickasaw Nation gaming facilities except Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Eligible Riverwind Casino employees who participate in the Blood Drive on Thursday, September 9, 2026, between 10:00am – 6:00pm will receive an offer of \$20 in Bonus Play at Newcastle Casino. Riverwind Casino Patrons who participate in the Blood Drive on Thursday September 9, 2026, between 10:00am – 6:00pm will receive an offer of \$10 Bonus Play at Riverwind Casino.
 - a.) Eligible Employees of Riverwind Casino who receive the offer will be able to obtain their Bonus Play at any participating electronic gaming machine at Newcastle Casino.
 - b.) All Bonus Play will for Employees be valid until 2 a.m. September 16, 2026
 - c.) All Bonus Play for Patrons will be valid until 2 a.m. September 10, 2026
 - d.) Eligible Employees and Patrons are eligible for one (1) offer during the promotion.
 - e.) All offers are non-cashable and non-transferable.
4. Any promotional prize awards or mail offers cannot be used towards earning promotional points.
5. Additional Incentive Cash moved to Flash Play needs to be played within 48 hours of download to the electronic game or it will expire.
6. Winner(s) are responsible for all applicable taxes. Winner(s) will receive a W2-G and/or a 1099 and/or 1042s tax form, when applicable, provided by Nation.
7. Acceptance of prize constitutes winner’s permission to use his/her likeness or name for publicity or promotion uses without compensation. Winner must agree to sign a publicity release form before prize will be released.
8. Any situation or dispute not covered by the above rules will be resolved by Nation in a manner deemed by them to be the fairest to all concerned and that decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time. Upon any dispute regarding this giveaway, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
10. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
