Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away four (4) cruise packages to the Spin & Sail Cruise Giveaway for the month of November 2026, to four (4) Riverwind Casino Patrons plus a guest.
2. Patrons must be 21 years of age or older with a valid photo I.D. and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All Riverwind Wild Card members will be able to earn points on all electronic gaming machines manufactured /distributed by Gaming Capitol Group (GCG) and IGT from 8:00am on Sunday, July 19, 2026, through 11:59pm Saturday, August 15, 2026.
 - a.) Electronic Table Games and Video Poker games are excluded from this promotion.
4. The top Diamond member overall and the top Three (3) patrons who earn the highest number of points during this time period will be rewarded with the prize of an eight (8)-day cruise aboard the Carnival Jubilee for the Spin & Sail Slot Tournament (valued at \$4,800). The top Diamond member will be rewarded with \$1,000 in cash.
5. Each trip includes:
 - a.) Balcony cabin, cruise fare, fees, taxes, required expenses and one (1) entry into the onboard \$1 million Wheel of Fortune Spin & Sail Slot Tournament.
 - b.) The winning trip is valid for November 14, 2026, through November 22, 2026.
 1. Carnival Jubilee cruise ship departing from Galveston, Texas on November 14, 2026.
 - c.) Winners will be announced on Tuesday, August 18, 2026, at 12:00pm. Patrons do not have to be present to win.
 - d.) Winners will be contacted via phone by a member of the Riverwind Promotions team. Once contacted, patrons will have three (3) hours to call and claim the prize. If not accepting of prize, or if the patron does not call to claim prize within the allotted time, the prize will be awarded to the next qualifying patron.

 7. Player's club benefits are exclusive to the account holder. Cards may only be used by the patron listed on the account to track play and earn points. Misuse or improper play, as determined by casino management, may result in loss of points, offers, and membership privileges, and could result in exclusion from Chickasaw Nation casinos.
 8. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes will be released.
 9. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
 10. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
 11. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
