Riverwind Casino
Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away up to a total of over \$300,000 in Cash, Bonus Play, and Prizes during our “\$300,000 Wild Card Blitz” promotion during the months of October 2026, through December 2026.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. All patrons who have a Riverwind Wild Card will be eligible to earn entries for drawings each Friday in October, November and December 2026 in the following ways:
 - a.) Beginning on Sunday, September 27, 2026, at 8:00am through 11:59pm Friday, October 30, 2026, and Sunday, November 1, 2026, at 8:00am through 11:59pm Friday, November 27, 2026, and Sunday, November 29, 2026, at 8:00am through 11:59pm Friday, December 25, 2026, patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
 - b.) Patrons will receive 9X entries on Mondays and Tuesdays starting Monday, September 28th through Tuesday, December 22nd, 2026.
 - c.) New Members will receive five (5) free entry into the drawing by signing up for a Riverwind Wild Card.
 - d.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
 - e.) Patrons are responsible for activating their entries by properly inserting their Riverwind Wild Card into any electronic gaming device and removing their Riverwind Wild Card within 30 minutes of each drawing time each Friday. Patrons must activate their entries prior to being eligible to win.
4. From 6:00pm to 11:30pm, October 2, 9, 16, and 23, November 6, 13, and 20, and December 4, 11, and 18. Preliminary Drawings will be held every 30 minutes where two (2) winners will be selected to each win a prize in the amount of \$350 in Cash and \$350 in Bonus Play.

 - f.) In the event of a “No Show”, or a winner declines the said prize a new winner will be redrawn.
5. From 6:00pm to 11:30pm, on October 30, November 27, and December 25. Preliminary Drawings will be held every 30 minutes where two (2) winners will be announced to play a game to determine the amount won. Winners will win one of the following prizes bundles:
- a.) (1) \$400 Cash + \$400 Bonus Play, (1) \$600 Cash + \$600 Bonus Play, or (1) \$800 Cash + \$800 Bonus Play.
 - b.) Prize amounts for Cash are as follows: (10) \$400, (10) \$600, and (4) \$800.
 - c.) Prize amounts for Bonus Play are as follows: (10) \$400, (10) \$600, and (4) \$800.
 - d.) Limit of one (1) preliminary drawing win per patron per promotional date.
 - e.) Patrons must be present to win, and when announced will be given four (4) minutes to report to the North Promotional Booth.
 - f.) Preliminary Bonus Play won will be valid until 2:00am.
 - g.) In the event of a “No Show”, or a winner declines the said prize a new winner will be redrawn.
6. At 11:59pm on Friday, October 30, November 27, and December 25. Two (2) Grand Prize winners will be announced to receive \$2,500 in Cash, \$1,000 in Bonus Play, and (1) Prize package Valued up to \$5,359.89. Prize Packages to be choose is as follows:

 - d.) All patrons are eligible for the Grand Prize drawing.
 - e.) Patrons must be present to win, and when announced will be given four (4) minutes to report to the North Promotional Booth.
 - f.) In the event of a “No Show”, or a winner declines the said prize a new winner will be redrawn.

- g.) Bonus Play won from Grand Prize drawings is valid until 2:00am.
7. Riverwind Casino's casino management system will be the sole determinant of each winner.
 8. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, and/or 1042s tax form when applicable, provided by the Chickasaw Nation.
 9. Player's club benefits are exclusive to the account holder. Cards may only be used by the patron listed on the account to track play and earn points. Misuse or improper play, as determined by casino management, may result in loss of points, offers, and membership privileges, and could result in exclusion from Chickasaw Nation casinos.
 10. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
 11. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
 12. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
 13. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
