

“Battle of the Bridge”
Monthly Sweepstakes Presented by GCG
Riverwind Casino & Goldsby Gaming Center
Official Rules

1. Riverwind Casino & Goldsby Gaming Center are governmental enterprises of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino and Goldsby Gaming Center together is giving away \$10,000 in Cash during the “Battle of the Bridge” Monthly Sweepstakes Promotion for the month of October 2026.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Wild Card member or a Goldsby Gaming Center Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during the promotional activity; employees of Riverwind Casino, and Goldsby Gaming Center; employee of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Starting at 8:00am Thursday, October 1, 2026, through 11:00pm Friday, October 30, 2026, patrons can receive one (1) entry for every five (5) points earned on all electronic gaming machines manufactured/distributed by Gaming Capitol Group (GCG). Patrons can earn their points at Riverwind Casino and Goldsby Gaming Center, but their points will remain separate and not be combined.
 - a.) Patrons can earn 7x the entries on Mondays and Tuesdays at Riverwind Casino and 7x the entries on Sundays and Wednesdays at Goldsby Gaming Center during each earning period.
4. A total of \$10,000 in Cash will be awarded at Riverwind Casino and Goldsby Gaming Center on Friday, October 30, 2026. Preliminary Drawings will be held at both Riverwind Casino and Goldsby Gaming Center every thirty (30) minutes where one (1) winner will be called from 6:15pm to 10:45pm. Each winner will be announced to win \$400 in Cash each.
 - a.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to respond to the North Promotion’s Booth at Riverwind Casino and three (3) minutes to respond to the Promotions Booth at Goldsby Gaming Center.
 - b.) If the announced winner does not respond within the allotted time or declines said prize, a new winner will not be drawn, and prize will go unclaimed.
5. At 11:15pm, one (1) winner will be drawn at both Riverwind Casino and Goldsby Gaming Center to win a Grand Prize of \$1,000 in Cash.
 - a.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to respond to the North Promotion’s Booth at Riverwind Casino and three (3) minutes to respond to the Promotions Booth at Goldsby Gaming Center.
 - b.) If the announced winner does not respond within the allotted time or declines said prize, a new winner will not be drawn, and prize will go unclaimed.

6. Patrons must provide a valid ID and Riverwind Wild Card or Goldsby Gaming Center Players Club Card to be deemed an official winner of any promotional drawings.
7. Riverwind Casino and Goldsby Gaming Center's casino management system will be the sole determinant of each winner.
 - a.) Limit of one (1) Preliminary Drawing prize and one (1) Grand Prize Drawing per Patron, per promotional date.
8. All electronic Table Games, and Wide Area Progressive electronic games will be excluded from this promotion.
9. Riverwind Casino's and Goldsby Gaming Center's manual drawing system will be the sole determinant of each winner.
10. Winner(s) is responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form and/or 1042s tax form, when applicable, provided by Chickasaw Nation.
11. Player's club benefits are exclusive to the account holder. Cards may only be used by the patron listed on the account to track play and earn points. Misuse or improper play, as determined by casino management, may result in loss of points, offers, and membership privileges, and could result in exclusion from Chickasaw Nation casinos.
12. Acceptance of prize constitutes winner's permission for the Chickasaw Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
13. Any situation or dispute not covered by these Official Rules will be resolved by the Chickasaw Nation in a manner deemed by the Chickasaw Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
14. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
15. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Chickasaw Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
