Official Rules

1. Riverwind Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Riverwind Casino is giving away a total of \$10,000 in Bonus Play every Wednesday during the months of October 2026 through December 2026, with the promotion beginning on Wednesday, October 7, 2026, through Wednesday, December 30, 2026.
2. Patrons must be 18 years of age or older with a valid photo I.D and must be a Riverwind Casino Wild Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Riverwind Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning at 8:00 a.m. each Wednesday, all patrons are eligible to earn entries for drawings in the following ways:
 - a.) Patrons will receive one (1) entry for every five (5) points earned on their Riverwind Wild Card. Partial entries will not carry over once drawings begin.
 - b.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
 - c.) Patron(s) is responsible for activating their entries by properly inserting their Riverwind Wild Card into an electronic gaming machine and removing their Riverwind Wild Card from the machine within thirty (30) minutes of each drawing time.
4. A total of \$10,000 in Cash and Bonus Play will be awarded each Wednesday. Preliminary Drawings will be held every thirty (30) minutes where two (2) winners will be called from 12:00pm to 4:30pm. Each winner will be announced to win \$75 in Cash and \$300 in Bonus Play each.
 - a.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to respond to the North Promotion’s Booth.
5. At 5:00pm, two (2) Patrons will be drawn to each win a Grand Prize for \$250 in Cash and \$1,000 in Bonus Play.
 - a.) Patrons must be present to win. Winner(s) will be announced and given four (4) minutes to respond to the North Promotion’s Booth. If the announced winner for a Grand Prize does not respond within the allotted time, a new winner will be drawn.
6. All Preliminary Bonus Play will be valid from time of download until 2:00am.
7. Patrons must provide a valid ID and Riverwind Wild Card to be deemed an official winner of any promotional drawings.
8. Riverwind Casino’s casino management system will be the sole determinant of each winner.
 - a.) Limit of one (1) Preliminary Drawing prize and one (1) Grand Prize Drawing per Patron, per promotional date.

9. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form and/or 1042s tax forms, when applicable, provided by the Chickasaw Nation.
10. Player's club benefits are exclusive to the account holder. Cards may only be used by the patron listed on the account to track play and earn points. Misuse or improper play, as determined by casino management, may result in loss of points, offers, and membership privileges, and could result in exclusion from Chickasaw Nation casinos.
11. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prizes are released.
12. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
13. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
14. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
